



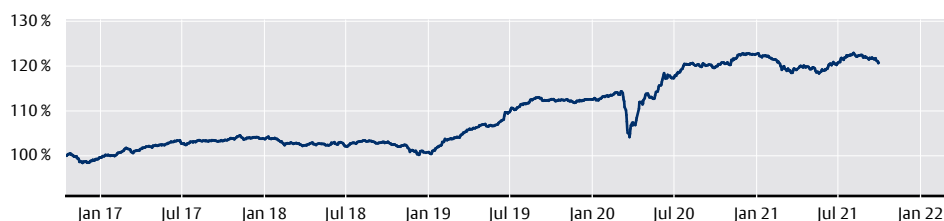
Flossbach von Storch - Bond Opportunities - RT

Flossbach von Storch investment sub-fund under Luxembourg law (mutual fund) and authorised for distribution in Portugal.

INVESTMENT STRATEGY

The objective of the investment policy of the Flossbach von Storch - Bond Opportunities sub-fund is to achieve reasonable growth while taking account of investment risk. The sub-fund invests predominantly in international convertible bonds and comparable securities. In addition to interest income from bonds, the result should be mainly determined by the profit potential from conversion rights into shares. An investment may involve a mixture of shares, bonds, investment funds and certificates, with the exception of certificates on hedge funds and certificates on hedge fund indices. However, no more than 10% of the sub-fund's assets may be invested in other investment funds. The subfund can utilise financial instruments whose value is dependent on the future prices of other assets ("derivatives") for hedging purposes or to increase its assets. The sub-fund is actively managed. The fund manager determines, regularly reviews and, if necessary, adjusts the composition of the portfolio exclusively in accordance with the criteria specified in the investment policy. The sub-fund is not managed in reference to an index. MONTHLY COMMENTARY

After a comparatively quiet summer, there were some movements to the markets in September. At the end of the month, there were fears that global economic growth could weaken also in the world's second largest economy, China, where the real-estate developer Evergrande ran into payment difficulties. Globally, ongoing problems in international supply chains have also been increasingly having a negative impact on growth expectations. In turn, producer prices have risen significantly, which formed the basis for rising inflation data. An easing in supply chains also seems to be postponed further into the future. Thus, central banks now find themselves with the dilemma of declining momentum in economic growth on the one hand and increased inflation risks triggered by the production bottlenecks on the other. The US Federal Reserve already seems to be reacting by considering the gradual phasing out of the bond-buying programme somewhat earlier than expected. Similar decisions are also on the agenda of the European Central Bank in autumn. Measured by the dynamics in the inflation data, there was only a slight rise in interest rates in the reporting period, which increasingly takes into account possible measures by the central banks. A possible structural and sustainable increase in inflation data, on the other hand, is not yet sufficiently reflected by the market in our opinion. In order to take this risk into account, the focus was shifted from bonds with longer maturities to shorter ones. Through a combination of sales, primarily of corporate bonds with long (to very long) maturities, and purchases of shorter-dated government bonds, as well as a buyback of corresponding hedges, the duration in the portfolio was changed, especially in terms of structure, but not yet reduced for the time being. In the process, the share of corporate bonds and thus the credit sensitivity in the portfolio also decreased.

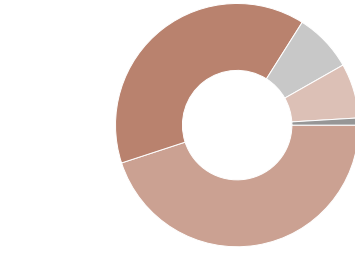
